Requests for competition bibs received later than 21 days before your event may not be fulfilled. Late requests are subject to availability.

AWARDS

Individuals: Provided for 1st through 10th place
Gold (1st), Silver (2nd), Bronze (3rd through 10th)

REGIONAL CHAMPIONSHIP: MEDALS (2 Sets Maximum per Division)

Individuals: Provided for 1st through 20th place.
Gold (1st), Silver (2nd), Bronze (3rd through 20th)
