The 2007 championship season is here and I want to cover a couple of important areas relating to the registration process starting this season. We will have early packet pick up **AND** advancement form verification this Friday evening, June 8, from 7:00-10:00 pm at the Holiday Inn Express in Roseville. The address is 1398 East Roseville Parkway; the telephone number is 916 774-6060.

The early packet pick up is for the Pacific Association Championships (PAC) track and field meet this weekend at Bella Vista High School in the Sacramento area. The advancement form verification is for the Region 14 Multi Event meet in Fresno on June 16<sup>th</sup> and the Pacific Association Junior Olympic Championships track and field meet (Top 8) being held at Granada High School in Livermore on June 22-24<sup>th</sup>. Please note: the **athlete verification process must be completed before** the beginning of the track meet on Friday, June 22<sup>nd</sup>. We have included quite a bit of information online in the PAC Championship and the Junior Olympic Championship literature currently on the youth schedule. This memo is just a reminder to reiterate the fact that:

- All entries should be entered using the Club Manager program for the Pacific Association Championship and the PA Junior Olympic Championship meets. The deadline for the PAC has come and gone; the PAJO deadline is June 13<sup>th</sup>.
- Before a meet entry is made, the athlete should be a current 2007 USATF member. Information on becoming a member is available on the PAUSATF website. <a href="https://www.pausatf.org">www.pausatf.org</a>
- Do not depend on obtaining your three-part form from meet management when you arrive at the PAC or JO meets. You must download the form, make enough

copies for every athlete who will compete in the JO Top 8 meet and bring those completed forms to the PAC meet this weekend **OR** contact Tony Williams to make other arrangements. You can find the forms on the PAUSATF website <a href="https://www.pausatf.org">www.pausatf.org</a> under the youth schedule dates of June 9-10 and June 22-24.

- The deadline date for verification is Friday, June 22<sup>nd</sup> prior to the start of the track meet. Per our Region 14 Coordinator Susan Johnson, no relay declaration forms will be accepted after the meet has started on Saturday morning June 23<sup>rd</sup>. Therefore, please come to the meet totally prepared with all forms completed and verified and with relay declarations ready to turn in. This will help facilitate the check-in and verification process more efficiently for us all and alleviate any confusion or disappointments for everyone.
- The adidas Golden West Invitational is a premier high school track meet that will be held at Folsom High School (approximately 15-20 minutes away from Bella Vista High School) on Sunday, June 10. Any youth athlete may attend the Golden West meet for free merely by showing their PAC competition bib number at the ticket booth.
