<u>Divisions:</u> 18 & Under, Open (19-29) (30-39), Masters (40 years and above in 5 year age groups). You must be registered with USATF in order to score grand prix points or to be eligible for championship medals.

Note: This race is being held in conjunction with the Los Gatos All-Comers meet. The 1 Hour Postal is the first event of the day.

- •\$25.00 registration race-day


