HX OF PRESENT ILLNESS/INJURY NARRATIVE: Arrived to find patient on the ground unconscious. Patient was a participant in a Half Marathon. Bystanders on scene had patient on her side. Patient was cool, pale, and diaphoretic. Patient only responsive to painful stimuli. Bystanders on scene stated patient suddenly collapsed and showed seizure activity. Placed patient on Oxygen via Non Rebreather Mask at a rate of 15 LPM. Patient would not tolerate mask, delivered blow by O2. Attempted vitals, unable to obtain patient was combative. Patient had weak radial pulse 60 BPM. Transfer to care to Folsom Fire Medic 35. Transport to Mercy Hospital Folsom.
