Congratulations on to completion of another successful Track and Field Season in the Pacific Association. We successfully progressed through the season and held several large college conference championships (Big West, Mountain West, JC- Big 8, CCCAA Nor-Cal) as well as CIF conference and section meets and ultimately, the USATF Masters Outdoor Championships. We were able to do this not only due outstanding meet management but with our great officials and the great training we've done in preparation. A highlight of the season was having 6 PAUSATF Officials named to the Olympic Trials held in Eugene, Oregon.

As we have recently had our Officials Annual meeting at UC Davis, I would like to thank the coaches and staff at UC Davis and particularly, Erika DeContreras, for the accommodations and lunch. Looking forward, this is a new Olympiad and therefore, a recertification year for all officials. Officials certified in 2024 will not have to renew their certification. Ajay along with the Regional Resource Coordinators will be helping officials move through the process. Approximately 304 officials will be undergoing recertification.
